# FROM THE PRESIDENT

The Goethe Society of North America has been seeking during the last several years to advance from an organization created and led by the established and distinguished professionals of its founding generation toward a more broadly based and expansive association in which scholars of every career stage, every affiliation, and every critical purpose or orientation may interact to promote increased understanding of Goethe and his contemporaries, their circumstances and intellectual debts, and, in a new millennium, their legacy to posterity. As Professor Thomas P. Saine-co-founder of the Society with Professor Meredith Lee—said in response to my request for advice on governance, "It is clear that your presidency has fallen in a time of transition between the easier-going ways of the older GSNA leadership and the necessity of achieving clarity of line."

In hopes of maintaining the upward direction of the Goethe Society's development as well as in recognition of a variety of developments since its founding twenty-seven years ago this month, I would like to propose a few technical changes in the Society's bylaws. Additional changes, including a

detailed definition more of the responsibilities of officers of the Society, may be in order and may be proposed by members of the Society for consideration by the entire membership. The following proposals seem necessary and sufficient at present. I present them to you with the approval of the members of the Board of Directors.

The changes in the bylaws of the Society proposed here will allow for electronic balloting and will change the requirement that a member of the Board reside in California to read that the Board will appoint a representative to the State of California. On the agenda for our December business meeting will be a proposal for a discussion of titles and terms of service of officers heretofore not recognized in the bylaws. In a subsequent electronic ballot, assuming the technical changes proposed in this edition of the newsletter, are approved, the membership will be asked to approve of a change of wording in Section III of the bylaws which will record that the Webmaster and Editor of the Newsletter is an ex officio member of the Board. The membership will be asked only to approve a rewording of the bylaws in such a way as to acknowledge the status quo ante. The fact of the Webmaster and Newsletter Editor's ex officio status on the Board was made official in 1991 and is in no need of further approval, but the bylaws have never been revised to record this addition. Other possible changes in the bylaws and the composition of the Board may be proposed and discussed at our December meeting. The present bylaws recognize two ex officio members of the Board-the Executive Secretary and the Editor of the Yearbook. Any changes in the bylaws, which are posted on the GSNA website, must be approved by "a two-thirds (2/3) majority of those responding to the mail ballot."

Please record your vote on the enclosed ballot and return it via U.S. Mail to Professor Burkhard Henke, Editor of the GSNA Newsletter, Davidson College, Davidson, NC 28035-6956.

I am happy to report that the three sessions sponsored by Goethe Society of North America at the recent German Studies Association convention in San Diego and directed by Dr. Angus Nicholls of the University of London were a great success—well attended, despite two of them being scheduled back-to-back early on Saturday morning, and stimulating lively discussion. The next edition of the *Yearbook*, vol. 15 is expected to come out in January, and Editor Daniel Purdy is now accepting manuscripts for possible inclusion in vol. 16.

Finally, let me add a word of thanks and praise for the work of Astrida Tantillo, who has decided not to stand for reappointment when her current term as Executive Secretary comes to а conclusion at the end of this year. Astrida has done the bulk of the administrative work of the Society for the past three years and has maintained close and conscientious contact with the membership of the Society, the Board of Directors, and the various societies with which we are affiliated, the GSA, the MLA, and the American Society for Eighteenth-Century Studies. She has been on top of every issue and has promptly and efficiently communicated with all concerned in a spirit of the utmost cordiality. She stays in office, of course, until the end of 2007 and will

remain in her position as Editor of the GSNA book series thereafter. An exemplary officer and member of the profession, she will be hard to replace as Executive Secretary. You will find below a job description for the Executive Secretary, and you are invited to submit nominations for this position (including your own name) to a nominating committee composed of Vice President Simon Richter, Director at Large Karin Schutjer, and myself. A new Executive Secretary will ultimately—and soon, necessarily—be appointed by the board of the Society as a whole.

# Nominations Invited Executive Secretary, Goethe Society of North America

The Board of the Goethe Society of North America invites nominations for the position of Executive Secretary. The Executive Secretary provides administrative and programmatic leadership for the GSNA and serves as an ex-officio member of the Board of Directors. An appointment will be made by the Board for a renewable three-year term, beginning January 1, 2008.

The position of Executive Secretary is responsible for sustaining GSNA programs and programmatic links with our affiliate organizations: the Modern Language Association, the American Society for Eighteenth-Century Studies, and the German Studies Association. The Executive Secretary, in consultation with the board, arranges panels at the annual meetings of these organizations and monitors the development of

convention Other programs. administrative matters, such as the periodic MLA recertification, require exceptional attention and a timely response. Attendance at the annual MLA meeting in December is mandatory. Attendance at the annual meetings of the ASECS meeting in March/April and the GSA meeting in October is also highly desirable. The MLA hosts the annual executive board meeting of the society, but board meetings may be called at the other annual conventions, e.g. to confirm the selection of winners of the annual essay prize and of Gloria Flaherty awards to graduate students, as well as to conduct other urgent business. The Executive Secretary drafts the agenda for the annual meeting, in consultation with the President and other members of the board.

The Executive Secretary facilitates communication among and between the society's officers, the Board of Directors, and the members. and responds to queries and requests from outside organizations. Communications with the Webmaster and Editor of the Newsletter and with the Secretarywho Treasurer, oversee the dissemination of society news and its financial/legal matters respectively, are especially important, as are the ability willingness and to facilitate conversations from a distance about matters pertinent to the mission of the organization.
